#### Dear NTVGCD,

We are presenting the following *revised* permit application package to support permitting a well field to be constructed in Anderson County (the southwest corner of the county; the property is 2/3 in Anderson County and 1/3 in Houston County) in the Redtown Ranch; this package addresses the requested changes by the district. This package relies on the latest scientific research available that has been conducted by LRE Water in May and August of 2024 which supports our volumetric request and provides hydrological analysis.

In the interest of simplicity and ease of analysis, we are submitting this request with this cover letter, this summary, 21 separate permit applications and the sustainability report. In the summary you will find the relevant well information in a table for ease of use. For the fees, the casing is to be determined, so we included the maximum amount of \$400 dollars per permit totaling \$8,400 to account for the largest possible casing in our original application.

All wells are set back ¼ mile from the property line and we included a list of neighboring property owners. The purpose for which drilling, and production is requested includes all beneficial purposes as those terms are defined in Section 36.001(9), Texas Water Code, and NTVGCD Rule 1(c), as the same may be amended from time to time. We will comply with District's rules and will comply with the Management Plan. We will comply with District plugging and capping guidelines.

We look forward to continuing to work with you through the permitting process; please reach out to us if you have any questions.

### Summary

Based on the scientific evidence gathered and analyzed by LRE (attached to this application), we are applying for 21 permits, 8 of which are in the Middle Wilcox, 8 of which are in the Upper Wilcox, and 5 of which are in the Carrizo Sands. These wells total expected production of 33,132 AF/yr. This is a conservative approach, as these numbers are projected to leave 30% of the remaining available drawdown in the system after 50 years as evidenced by the included report. The following table lists the wells by aquifer and includes the data required in the NTVGCD permit application.
